Eligibility requirements:

- Student must complete the scholarship application **prior to the end of the drop/add week of the term** to receive the scholarship for that term. (Awards are not retroactive before the scholarship application date.)
- Student must be enrolled in the NAU Master of Management (MM), Master of Business Administration (MBA) or Master of Science in Nursing (MSN) degree program (Special not eligible).
- Student must be one of the following:
 - Graduate of South Texas College **OR**
 - Employed by South Texas College
- Scholarship of up to:
 - \$154 per credit hour beginning with the July 7, 2016 term
- This scholarship is available to eligible students who do not receive a reduced tuition rate.
- Scholarship based on eligibility and date of application, until the fund is exhausted

Retention requirements:

- Student **must submit a new scholarship application each Federal Award Year** (Summer term begins the Federal Award Year).
- Student must continue to be enrolled in an NAU Master's program (Special not eligible).
- Student may not take more than one term off during the Federal Award Year or they will lose eligibility for the scholarship.
- Student must maintain a cumulative grade point average (CGPA) of at least 3.0.
- Student must be Good Standing according to the Satisfactory Academic Progress standards to receive the scholarship; this is checked each quarter at the time of disbursement.
- If scholarship dependent on employment by South Texas College must continue to be employed by South Texas College.
- If the student fails to meet any of the above retention requirements, they lose eligibility for this scholarship.
